Refer to ORC section2305.321 (A))(7) (a-e) I authorize MSC, its assigns and transferees to copyright, use and publish, in print or electronically, photographs or videos of ,myself, or my child with or without my name, for any lawful purpose, including publicity, advertising or web content.
